

IF you missed this online forum, you can still purchase a ticket \$15US and access most of the recorded seminars until May 16<sup>th</sup>.

A recent news item may have caught some of our attention as a follow-up to Phil R's item in **Beaver Tales** February 2020, when he reported that The Outdoor Rec Council, (of which RCABC and Beaver Canoe Club are members), gained intervenor status in a court case that pitched private property rights against the public's right to roam to access Crown lands within the boundaries of private land. This March the Court sided with the billionaire land owner of Douglas Ranch, delivering a blow to the public's right to access its own land. In this case the land in dispute was actually a couple of bodies of water, namely lakes, that fishers (and potentially canoeists) would have liked access as in the past. A letter to *The Vancouver Sun*, (March 13, 2021), by Charles Leduc of Vancouver, encaspulated the issue:

#### Res U.S. billionaire wins battle to keep anglers off his giant B.C. Ranch

The final verdict in the Douglas Lake Ranch case is not surprising, considering the long-standing bias in the B.C. legislature in favour of wealthy landowners, developers, mining companies, and so on. But the ruling judge Peter Willcock's decision to also have the Nicola Valley Club pay the defendant's legal costs, on the basis they aren't a "public interest litigant", is egregious.

The very fact B.C. law doesn't explicitly protect right-of-way to access public lands is, to my mind, exactly why this case is of utmost public interest.

Now we can only hope an appeal to a higher court will be given the go-ahead as this goes to the heart of Canadians' inherent right to enjoy their own publicly owned natural heritage.
